Patrick S. Adams has been a portfolio manager for approximately 26 years. Mr. Adams began his career in 1985 as a portfolio manager. He managed funds with Founders/Dreyfus Asset Management from March 1993 through June 1996. He subsequently held the position of Senior Vice President at Zurich Kemper Investments from July 1996 through January 1997. From February 1997 through May 1999, he served as Executive Vice President and Portfolio Manager for various funds at Berger Associates, Inc.

At Berger, Mr. Adams served as the Senior Investment Officer of the Berger Select Fund and co-portfolio manager of the Balanced Fund, both U.S.-registered investment companies. In addition, Mr. Adams managed the Berger 100 Fund, a mid-cap registered investment company. The assets of these funds totaled approximately \$2 billion. Prior to joining Berger, Mr. Adams led efforts to revitalize the \$2.7 billion Kemper Growth Fund, also a registered investment company. From March 1993 through May 1996, Mr. Adams was with Denver-based Founders Asset Management as lead manager of the \$450 million Blue Chip Fund and \$200 million Balanced Fund.

In May of 1999, Mr. Adams left the Berger Funds to form the Advisor and the General Partner, Choice Investment Management, LLC. He has been associated with Choice Investment Management, LLC since November 1999 and PVG Asset Management since 2008.

Mr. Adams received a Bachelor of Science degree in Finance and Accounting from Ohio State University, an MBA degree in Finance from Xavier University in Cincinnati, Ohio and earned the designation of Chartered Financial Analyst (CFA) in 1989.
